VII. Financial Services Report – Mr. Carey Tucker presented the following:

A. November Monthly Statements

November 2015 highlights included total unrestricted revenue of \$5,825,011.26 which is 39.2% of the total

budget of \$14,858,572.00. Total unrestricted expense of \$5,817,030.43 was 39.15% of the total budget of

\$14,858,572.00. Total revenues over expenditures at November 30, 2015 was \$7,980.83. Total cash and

investments at November 30, 2015 was \$6,748,728.21.

B. December Monthly Statements

December 2015 highlights included total unrestricted revenue of \$6,588,643.13 which is 48.05% of the total budget of \$14,707,272.00. Total unrestricted expense of \$6,843,732.09 was 46.53% of the total budget of \$14,707,272.00. Total expenditures over revenue at

December 31, 2015 was \$255,088.96. Total cash and investments at December 31, 2015 was \$6,601,488.01

VIII. President's Report – Dr. Barbara Jones

A. Administrative Reports

Vice President for Finance and Administration – Mr. Carey Tucker

- 1. The city approved the purchase of an electrical scissor lift for use inside the conference center and have begun the process of seeking bids.
- 2. 25 events were scheduled in the conference center in December.
- 3. The architects from Polk. Stanley, Wilcox submitted a draft of the new master plan, with final document expected in the near future.
- 4. Two on-call architects were approved by the Legislative Council on January 12th: Polk, Stanley, Wilcox Architects, Little Rock; and CADM Architecture, Inc., El Dorado.
- 5. A table top review of the emergency action plan was conducted by the Cabinet.
- 6. Mr. Tucker briefed Emergency Procedures to faculty and staff during Convocation.

<u>Vice President for Learning – Dr. Mickey Best</u>

- 1. The new FIT Grant Project Manager, Claudine Forte-Johnson, is on-board and making visits to high schools.
- 2. Kudos to the maintenance staff for the timely process of renovating the Welding area with no down time.
- 3. The Secondary Technical Center will start a new Industrial Technology Mechatronics program in August of 2016 adding to the current post-secondary class.
- 4. Emergency Medical Technician (EMT)/Paramedic: exploring and setting up the 'Community Paramedic' program.
- 5. Nursing: Worked with 3 other programs within ARNEC on application for USDA Delta Regional Authority grant, which would provide funds for additional simulation equipment.
- 6. Preliminary results on last year's pilot project to require a lab experience for College Algebra students suggest that the labs help to improve student success rates. During the spring 2015 semester when students started attending two fifty-minute labs each week, the pass rate went up to 64%. Last semester, the rate went up to 79%.
- 7. Vernita Morgan, assistant professor of math and coordinator of the basic studies math program, has been nominated to serve as the college's representative in the Mathematics Pathways to Completion (MPC) project which being coordinated by the Charles A Dana Center at the University of Texas.

<u>Vice President for Student Services – Dr. Jim Bullock</u>

- 1. The Learning Center has developed through BlackBoard an online tutoring system in the academic areas of mathematics, writing, and science. All Spring 2016 students will be enrolled in online tutoring as a BlackBoard course so that they can have access to this service if they need it
- 2. SouthArk has been approved through the Louisiana Department of Education's Office of Student Opportunities to offer concurrent credit as a Course Choice/Supplemental Course Academy course provider to high school students at Northeast Claiborne Charter School as well as any other school under the jurisdiction of the Louisiana Board of Elementary and Secondary Education (BESE), if approached. Beginning in the 2016-2017 academic year, we will be able to offer any course on the curriculum of the Certificate of General Studies and Associate of Arts as well as any program in the Secondary Technical Center to students in these schools. Additionally, this service will be at no cost to the students

- but will be paid through funding provided by the Supplemental Course Academy of Louisiana.
- 3. The Division of Student Services, led in a project by director of student advising coaches Dr. John Spencer, has developed a virtual "Retention Center" to assist faculty in their efforts to increase student engagement, retention, and success. This page on the SouthArk website lists potential challenges that faculty might face in keeping students productively engaged (i.e. attendance, poor academic performance, disruptive behavior, or personal issues) and directs faculty to the appropriate procedure or person to address a given issue.

Chief Information Officer – Dr. Tim Kirk

- 1. Jenzabar staff will be onsite thirty-four (34) of the next fifty (50) business days to conduct additional training.
- 2. Final pass data extraction/conversion will begin March 18, 2016 with SouthArk live on Jenzabar EX April 1, 2016.
- 3. Information technology staff have installed the desktop alert (panic button) software in all classrooms and is working with faculty and staff to deploy in individual offices.
- 4. Firewall and router upgrades were completed during the Thanksgiving and winter holiday breaks. These upgrades not only improved the security of the SouthArk network, they permit us to make full use of ARE-ON's revised Internet access policies.

- 1. The new Corporate Education Catalog has been created and published. The current version includes an increased list of soft skills courses for business and industry.
- 2. Corporate Education will soon be offering non-credit classes at the new classroom in Warren. Initial requests include computer and management training.
- 3. Amy Sturdivant is the new Director of Adult Education. The department is preparing for a site visit from the state.
