- Catastrophic Leave Bank The State has now excluded SACC from the Catastrophic Leave Bank effective December 5, 2014. SACC is allowed to create and administer a catastrophic leave bank. A draft policy is distributed for your review and will be an <u>Action item next Cabinet meeting</u> in order to meet the Dec. 5<sup>th</sup> deadline to OPM.
- Health Care Reform The Affordable Care Act changes require benefits to be offered to employees based on actual hours worked irrespective of job classification (extra help, student workers, adjunct faculty, etc.) or incur significant financial penalties (1/12<sup>th</sup> x \$2,000 x # of FTE over 80). Any employee who averages over 30 hours a week must be offered benefits for them and their dependent children up to age 26. Additional penalties occur if the health coverage is unaffordable (more than 9.5% of household income) or inadequate (actuarial value of less than 60%). The school's annual Measuring Period will be November 1 through October 31 with an Administrative Period from November 1 through December 31. Employees who enter employment after November 1<sup>st</sup> will have their own individual 10 month measurement period followed by a 2 month administrative period where their hours are calculated, they are offered health insurance if eligible, and they have to accept/refuse at the end of that 2 month period. An employer information guide is distributed for your information.
