A. November Monthly Statements

November 2019 highlights included total unrestricted revenue of \$6,006,326, which is 41.97% of the total budget of \$14,308,825. Total unrestricted expenses of \$5,773,574, which is 40.34% of the total budget of \$14,308,825. Total revenues over expenditures at November 30, 2019 were \$232,752. Total cash and investments at November 30, 2019, were \$6,816,203.

B. December Monthly Statements

December 2019 highlights included total unrestricted revenue of \$6,779,447, which is 47.37% of the total budget of \$14,311,210. Total unrestricted expenses of \$6,792,399, which is 47.46% of the total budget of \$14,311,210. Total expenditures over revenues at December 31, 2019 were \$12,952. Total cash and investments at December 31, 2019, were \$6,567,059.

A. Administrative Reports – highlights from reports

Vice President for Finance and Administration – Mr. Carey Tucker

- The ACAP house, the PBL clothes closet and food pantry, and Edi's Village all have roofs.
- ARState construction began renovation of the 1940 Gymnasium.
- A Jenzabar consultant is scheduled to update the retention module.
- An updated College Emergency Operations Plan is being distributed.
- The TPA for the AHEC health insurance changed to Blue Cross/Blue Shield in January 2020.
- APM changes were made to APM 3.08, Discretionary Leave; and a new APM was added for 2.50, Merit Bonus email was sent out to all employees of changes.

Vice President for Academic Affairs – Dr. Michael Murders

- Fall Graduation was successful with nearly 263 graduates with approximately 180 walking at commencement.
- Monieca West from ADHE presented on "Bridges Out of Poverty" at Convocation.
- Secondary Technical Center has received an equipment grant from the Office of Skills Development (OSD) for \$163,675.56 to acquire needed equipment in the automotive and welding programs.
- ARNEC is finalizing a 2+2 agreement with UCA for all eight participating colleges for the RN to BSN program.

Vice President for Student Services – Dr. Derek Moore

- Spring enrollment as of 1/10/20 had an unofficial headcount of 1,218.
- Renovations to the SouthArk gym are scheduled to be completed in May.

- Carl D. Perkins (Career & Technical Education) program staff are scheduling area meetings to share results of a recent comprehensive needs assessment; which will be included as part of SouthArk's application for the upcoming grant cycle opportunity.
- An assessment of renovation needs for utilizing the former Red Cross Building for a Student Center is underway.
- Alumni recognition January 25th 4:00 p.m.

Associate VP for Institutional Planning & Academic Support – Dr. Stephanie Tully-Dartez

- IPEDS winter data input has commenced and the 150% completion rate for the 2016 Fall cohort has preliminarily come back at over 30%.
- The annual C-STOP total participation was 1,482; which is a 6% increase over the previous year.
- Adult Education had 9 GED graduates and 81 Wage Certificates in 2019.
